- Fireboard Report—Timothy Saleski stated there were thirteen runs in the county with zero for Hay Twp. The Fire chief has a new budget proposal and will be voted on at the December board meeting. - Supervisor Comments—Supervisor Doyle spoke of the need for a new IT phone system. Clerk, Supervisor & Treasurer had zoom call with Callharbor to discuss features of interest to the township office. Discussion followed covering installation and training for the staff and the 24/7 support system. - Supervisor Doyle added that an invoice had been sent for grass mowing under the new blight ordinance.
- The supervisor mentioned there was a brief discussion concerning the Highwood Bridge during meeting with the Gladwin County Road Commission. The staff were planning on changing their gmail accounts over to .gov accounts for added security, but it will have to wait until the government shut down ends. Supervisor Doyle attended the Smallwood Lake Association Meeting, and the association is setting up a plan to get the lake ready for water. The clearing of trees and brush will be taking place.
