

**HAY TOWNSHIP**  
**Unapproved Minutes of November 20, 2025**

The Hay Township Board met on Thursday, November 20, 2025, in regular session. Supervisor Doyle called the meeting to order at 7:00 p.m.

- Fireboard Report—Timothy Saleski reported there were twenty-three runs in the county and only one in Hay Township. The Chaplain spoke about receiving a grant for smoke alarms that will be free to residents. There were more discussions about making the fire chief full-time and the possibility of an increased millage. Supervisor Doyle expanded on the fire department's budget.
- Ordinance Report—Dollar General, B & B, and Riverhouse, were inspected and found to be in compliance with LCC rules and regulations.
- New Complaints—1333 E. Heil Rd.—Junk. Misc junk and garbage in the yard. Notice was sent to the owners. Some clean-up has been done. Owner has approximately two weeks to finish cleaning the property.
- Old Complaints—770 Orbe Ct.—Grass violation. Grass was mowed.  
2162 Hillside-Junk. Lots of progress. Court was held on this case in November. Property owner was given until December 4<sup>th</sup> to complete clean-up. There will be a hearing at district court on that date. If satisfactorily cleaned up the case will be dismissed.  
Lot 9, Key Ct Mobile Home Park-Blight. Formal hearing in district court was scheduled for November 25<sup>th</sup>. New court date is December 9<sup>th</sup>.
- Greenways Inspection Report—Greenway Provisioning Center was inspected and found to be in compliance with LARA rules and regulations.

- **New Business—Budget Amendment \$7947.50 to account # 101-265-933 Parking Lot & Grounds Repair-Motion by Clerk Griffin, support by Trustee Monaghan to approve Budget Amendment of \$7947.50 to account # 101-265-933. M/C.**
- **New well—The new well was tested and was viable. The well went seventy-eight feet and a new pressure tank and valve were installed.**
- **Callharbor Phones—Hay Township switched over to a new phone system with many new features and new messages added.**
- **Mosquito Abatement Bids-Hay Township placed an ad for bids for mosquito abatement, APM was the only company that responded. If given the bid, the spraying would start around Memorial Day and run through the Labor Day holiday. Total cost to the township would be \$67,475.00.**
- **Public Comments—Stephanie Stevens, president of the Smallwood Lake Association, commented that the lake bottom is coming along nicely and that grants should be available from the DNR for cleaning up the marshier areas. They are planning on stocking the lake with fish in 2027.**
