Unapproved Minutes of September 18, 2025

The Hay Township Board met on Thursday, September 18, 2025, in regular session. Supervisor Doyle called the meeting to order at 7:00 p.m.

The Pledge of Allegiance was recited.

Roll Call: Monaghan absent, Griffin present, Doyle present, Kludt present, Becker present.

Commissioner's Report—Gladwin County approved Pratt Lake to have an advisory committee. The county applied for a grant "my neighborhood" for \$400,000 towards home repairs. County received \$280,000 grant to use for the replacement of the elevator in the courthouse, and the county balanced their budget.

Guests: Robert North—Gladwin County Emergency Management—Robert North spoke of the importance of fire wells in the county. He asked for Hay Township's support in installing a fire well with a backup generator at the Hay Township Hall. Motion by Supervisor Doyle, support by Clerk Griffin to sign the agreement to install a fire well at the Hay Township Hall. M/C. North also mentioned the Local Council of Government will meet at Secord Township Hall on September 29 at 6:30.
