Unapproved Minutes of August 21, 2025

The Hay Township Board met on Thursday, August 21, 2025, in regular session. Supervisor Doyle called the meeting to order at 7:00pm.

The Pledge of Allegiance was recited.

Roll Call: Trustee Monaghan present, Clerk Griffin absent, Supervisor Doyle present, Treasurer Kludt present, Trustee Becker present.

Commissioner's Report- Commissioner O'Donnell reported that the Chill Grant will be helping 25 homes with needed repairs. A similar grant called My Neighborhood Grant has been applied for. The Hazardous Waste Collection went well. Community Mental Health has funds available to help with mental help resources for Gladwin County residents. The Sheriff's department is in need of deputies again.

Guests- Mike Pichla from PLM spoke about controlling the invasive weed species on Smallwood Lake.

Fireboard Report- Tim Saleski reported there were 36 total fire runs, 3 were in Hay Township. Parking lot at the fire department has been resealed. Fire Dept. also purchased a new commercial washing machine.

Ordinance Report- Dave Kelly reported that lot 9 of Key Court Mobile Home Park was issued a citation. The 2 parcels on Andy's Lane have improved. A new complaint on Hillside Drive was received. Grass Ordinance update- Oren Ct. and Bushong Beach properties have been mowed. Property on Laurel Dr. has 15 days to get grass mowed.

Liquor Inspection Report- all properties were in compliance

Greenways Inspection Report- was also in compliance

Update on road gravel projects- Hay Rd. north of Highwood Rd and Wyman Rd. north of Highwood Rd. were graveled at a cost of \$45,135. Motion by Monaghan to approve the payment. Support by Doyle. M/C

Discussion on the Grass Ordinance. Motion by Doyle to change the notification sent to the property owner not in compliance from registered letter to certified letter. Support Kludt. M/C

2nd Public Comments- Stephanie Stevens was thankful for the grass ordinance. She also commented on the Smallwood Lake weed control and that these funds can be used to remove the trees.

Supervisor Comments- Resurfacing on Winegars Rd. is completed. Update given on possibly offering mosquito control. The township generator has been serviced.
